April Meeting Minutes

Minutes were reviewed. Motion made by Pat DeCelie to approve, and Torbin Winther seconded. All present approved.

President's Report – Linda Hall Winther

Review of the past year – Linda is very proud of all the work that was accomplished over the past year, starting with the review and updating of the GRMPA bylaws, the improvements of the concessions stand at Hurrell Field, the great Marching Band show, the fruit sale kick-off at the GR Train Station with the Marching Band & Color Guard greeting commuters on their way home, the Marching Band Dinner, the trip to Boston, the Summer Music Academy being spun off to Luanne Dragone, the Trumpets fundraiser, and having most of the Volunteer Chairs being filled. Overall, all the fundraisers did better this year than the prior two years or so.

President for next year is Paul Byrne. All important documents have been handed off in either "box file", flash drive, or dropbox file format.

Music Director's Report – Kevin Lagos

Boston Trip – The trip was great. They had amazing clinics in which all the adjudicators were all very positively oriented and focused on how the students could become better musicians. They spent quite a bit of time at Quincy Market and the Aquarium.

Arts Festival – The two school Jazz Bands will be performing in the morning at the festival. They have done very well given that quite a few rehearsals were missed due to several factors.

Fall Sports Sign-up – Starts May 27th. The Marching Band will be graduating out 11 seniors and there are currently 15 8th graders. Marching Band needs to be talked up to this group – there are quite a few that are athletically-oriented and may decided to chose another sport over Marching Band.

Fall 2014 Marching Band Show – Tentatively called "This is the End" with endings from famous music pieces compiled together to create it. The show will draw from the more famous Glen Ridge shows such as Firebird, Beethoven's Ninth, the 1812 Overture, etc.

Rumor has it that a new person was in charge of US Bands last fall and changed a bunch of the items that most people found objectionable to be less so.

Going to the Independent circuit was certainly cheaper in terms of registration fees, as well as the benefit of having the shows closer to home. US Bands had more expensive fees to pay and the venues were further away.

Something that the school administration needs to be aware of is the timing of the hiring of a new Marching Band Director is important as well as the benefits of having the band director and marching band director being the same person.

It was suggested that some of the GRMPA officers and involved parents meet with Mr. Philips to let him know of these issues.

A potential problem that may arise two years from now is the strings program and that of parents paying for a salaried staff member to give instruction to string players.

Treasurer's Update - Diane Chirco

At this time, all bills have been paid. What is still to come in the next month are the Senior Scholarships and the Concert Band Dinner. There are five applicants for the scholarship.
